Ring: The ring is indoors and on mats, no heat/air conditioning available. This is a single ring event with a maximum ring size of 24 x 24 feet.

Blind: The 12 x 12 blind is located indoors and will be limited to four dogs.

Move Ups: Move-ups/lateral moves are allowed Trial to Trial. Move ups must be given to the trial secretary at least 30 minutes before the start of the next trial. No move-ups will be allowed on Sunday, Dec. 4th.

Entry Limits: Judge is limited to 8 hours of judging and a maximum run value, which will require this club to limit entries accordingly. If the event is not full by the closing date, Late or Day of Show entries may be accepted until the judging limits are reached. Confirmations will not be sent for late entries.

Entries: Entries are accepted by mail or hand delivery on or after the entry opening date as noted in the trial entry form. Entries are not accepted via email, text, or other messaging platforms. Entries must be complete with payment and have valid physical or digital signatures. Entries **received** between the opening date and closing date pay the pre-entry fee rate. Entries **received after** the closing date pay the Late/Day of Show entry fee rate.

Route 66 Barn Hunt of Oklahoma (the Club) reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the Club or any official thereof. Dogs may not be brought to the gate in any disallowed collar or on a Flexi-lead. Dogs **MUST** run “naked,” without a collar/harness. Dogs should be brought to the ring with collars/harnesses which can be easily and quickly removed and replaced.

Bitches in season may enter this trial but are required to be kept separate from all other dogs and will be run at the end of their class/trial. They must wear pants/britches at all times including on the course. Entry fees for bitches that come into season will be refunded until closing time of the trial if you wish to withdraw. If bringing a bitch in season, please inform the trial committee prior to the trial, and you must inform all exhibitors at the Judge’s briefing. Judges are not required to wait for dogs. The owner or handler of each is solely responsible for having the dog ready when his/her class is to be judged.

It is expressly understood that participants are responsible for the behavior of their dog(s). Participants whose dogs create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the event committee, be asked to leave the event site. In such a case, no refund of any fees paid will be made. The Club will assume no responsibility for any loss, damage or injury sustained by participants or spectators, or to any of their dogs or property.

It is your responsibility to read and be familiar with BHA rules, which includes but not limited to facility grounds, collars and leashes allowed, cell phone/smartwatch policy. It can be found at www.barnhunt.com.

A final confirmation of further scheduling details will be e-mailed to all exhibitors before the trial. If you do not receive an email, please contact the trial secretary. Dogs being handled by the same person will be separated into different staged groups. Dogs may be measured at the discretion of the Judge.

Height Divisions:

- Small: Dogs 15” & under
- Medium: Dogs 15.1” to 22”
- Large: Dogs over 22”

Refund/Withdrawal policy:

Entry fees will be refunded

- If the entry is withdrawn prior to the closing date.
- If the competitor who entered the trial must withdraw due to suspected or confirmed COVID-19 or direct exposure to a COVID-19 patient.
- If the event must be canceled by BHA, State, or local authorities.
- If the entry is withdrawn after the closing date, and there is someone on the waitlist to take the withdrawn spot.

Entry Fees Not Refunded

- If the entry is withdrawn after the closing date and does not qualify for a refund exception.
- In the event that a dog is absent, disqualified, excused, or barred from competition by the action of the Event Committee.
- If the trials cannot open or be completed by reason of riots, civil disturbances, fire, and act of God, public emergency, act of a public enemy, or any other causes beyond the control of the Event Committee.

NOTICE TO EXHIBITORS

- Please expect to crate out of your vehicle. Indoor crating is available, but limited (no tents, or X pens indoors).
- Bring your own water and bowls for your dogs.
- Possessing or training with personal, live quarry is not permitted on the show grounds at any time.
- Dogs must be on a leash at all times except when in the ring.
- Leashes cannot be left dangling or dragging.
- Exhibitors are responsible to clean up after their dogs. Potty areas designated by the club will be clearly marked.
- Exhibitors are responsible for being ready to go to the staging area, in the staging area, and waiting for the call to the gate when it is their turn to run. The Judge need not wait for any dog holding up a class.
- The Club assumes no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, spectators, or to any of their dogs, property, or children.
